Pie Funds will, always, keep your information confidential and retain it only for as long as is required by law. Where necessary, we may need to disclose your information under compulsion of law, or where required by regulatory agencies (including the Financial Markets Authority or our supervisor, Trustees Executors Limited) or to any tax authority, or to our professional advisers where reasonably necessary for the performance

Pie Funds will also use the information in accordance with the requirements of the Anti-Money Laundering and Countering Financing of Terrorism Act 2009 including for the purposes of electronic verification, and may disclose information to such carefully selected external and independent agencies and entities as it considers appropriate for this purpose.

As a New Zealand Financial Institution, we are required to classify you for the purposes of the United States Foreign Account Tax Compliance Act ("FATCA") and the OECD Common Reporting Standards for Automatic Exchange of Financial Account Information ("AEOI") to meet our due diligence obligations.
