What is the purpose of this update?

This document tells you how the JUNO Balanced Fund has performed and what fees were charged. The document will help you compare the fund with other funds. Pie Funds Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Balanced Fund seeks to provide investors with steady capital growth over a five-to-10 year period. The Fund invests in equities (directly and/or through the JUNO Growth Fund), with a reasonable allocation towards fixed interest.

How has the fund performed?



The market index is a composite index (20% S&P NZX Investment Grade Corporate Bond Total Return Index (NZD)/50% MSCI ACWI IMI Net Total Return Index (NZD)/10% NZBond Bank Bill Index/10% Bloomberg Barclays Global Aggregate Total Return Index Hedged (NZD)/10% S&P/ASX All Ordinaries Total Return Index (NZD)). The market index has changed since the last fund update to reflect the revised target asset allocations in the updated SIPO. In particular the MSCI ACWI IMI Net Total Return Index has decreased from 60% to 50% and the S&P/ASX All Ordinaries Total Return Index (NZD) is now also included at 10%. The Bloomberg index is now hedged rather than unhedged to reflect a more accurate measure.

What are the risks of investing?

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.

Lucy had \$35,000* in the fund at the start of the year and did not make any further contributions. At the end of the year, Lucy incurred a loss after fund charges were deducted of \$6,705 (that is -19.16%** of her initial \$35,000). Lucy did not pay any other charges. This gives Lucy a total loss after tax of \$6,680 for the year.

*This figure has been used as it represents close to the average contributing KiwiSaver Scheme member's balance in 2021 (\$35,000) (FMA News and Resources, 4 October 2021).

**This percentage return after deducting the total fund flat fee of \$240p.a. Fee based on fund balance of \$35,000.


What does the fund invest in?

Hedging: We actively manage all currency exposure. It is not our intention to 100% hedge the currency at all times; some overseas securities may be unhedged. The hedged foreign currency exposure (as a percentage of the total foreign currency exposure in the fund) is 60.07% (unhedged 39.93%).
