# What is the purpose of this update?

This document tells you how the JUNO Balanced Fund has performed and what fees were charged. The document will help you compare the fund with other funds. Pie Funds Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

#### **Description of this fund**

The Balanced Fund seeks to provide investors with steady capital growth over a five-to-10 year period. The Fund invests in equities (directly and/or through the JUNO Growth Fund), with a reasonable allocation towards fixed interest.

# What are the risks of investing?


## How has the fund performed?

## **Example of how this applies to an investor**

Small differences in fees and charges can have a big impact on your investment over the long term.

Lucy had \$35,000\* in the fund at the start of the year and did not make any further contributions. At the end of the year, Lucy incurred a loss after fund charges were deducted of \$6,264 (that is -17.90%\*\* of her initial \$35,000). Lucy did not pay any other charges. This gives Lucy a total loss after tax of \$6,372 for the year.

**Hedging:** We actively manage all currency exposure. It is not our intention to 100% hedge the currency at all times; some overseas securities may be unhedged. The hedged foreign currency exposure (as a percentage of the total foreign currency exposure in the fund) is 89.81% (unhedged 10.19%).
