What is the purpose of this update?

This document tells you how the JUNO Growth Fund has performed and what fees were charged. The document will help you compare the fund with other funds. Pie Funds Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Growth Fund seeks to maximise capital growth for members, over 10 years or more. The Fund invests primarily in international and Australasian equities with a focus on globally-known brands, along with a cash and fixed interest exposure.

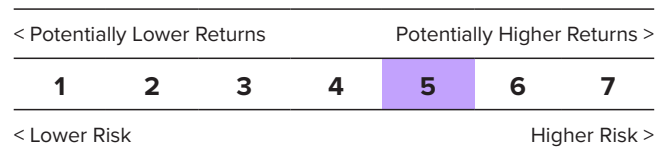

What are the risks of investing?

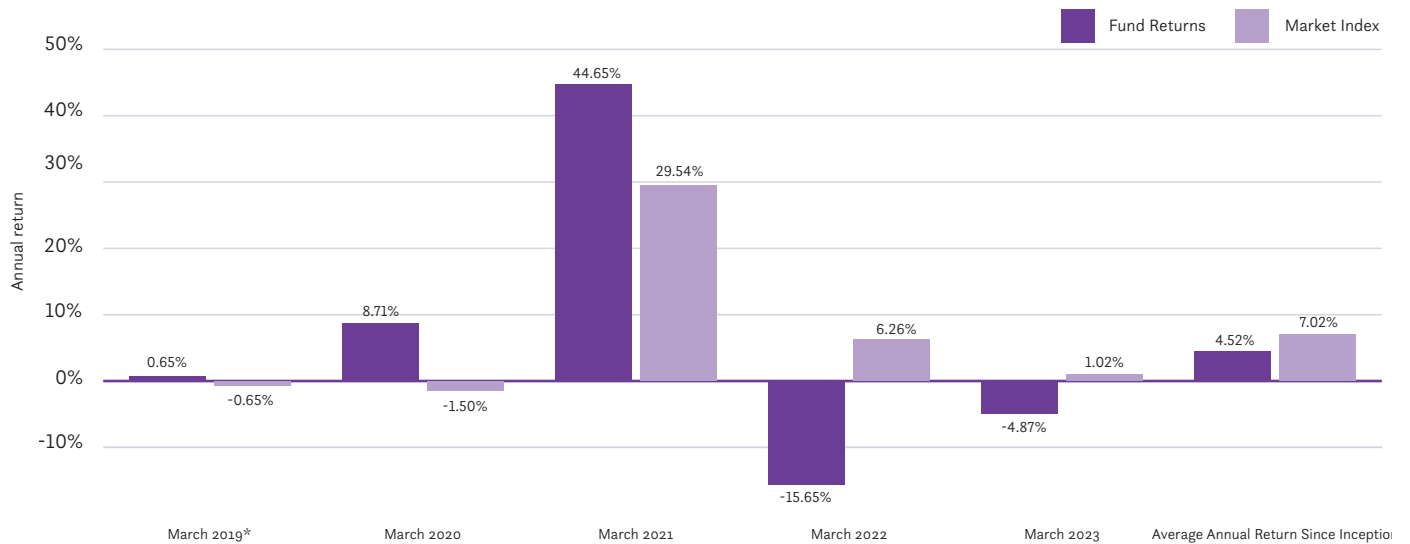

Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.

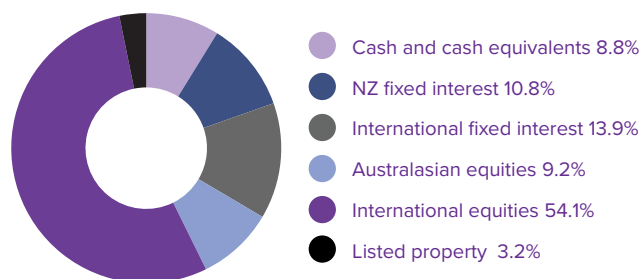
Emma had \$35,000* in the fund at the start of the year and did not make any further contributions. At the end of the year, Emma incurred a gain after fund charges were deducted of \$3,691, (that is 10.54%** of her initial \$35,000). Emma did not pay any other charges. This gives Emma a total gain after tax of \$3,037 for the year.

*This figure has been used as it represents close to the average contributing KiwiSaver Scheme member's balance in 2022 (estimate provided by FMA).

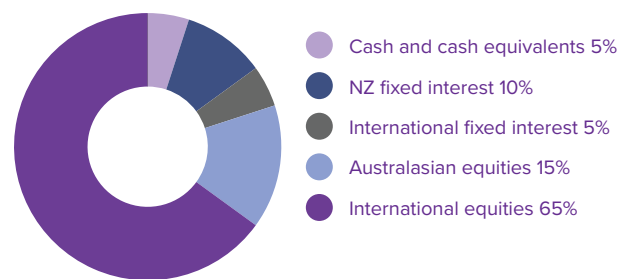
**This is the percentage return after deducting the total fund flat fee of \$240 p.a. Fee based on fund balance of \$35,000.

Hedging: We actively manage all currency exposure. It is not our intention to 100% hedge the currency at all times; some overseas securities may be unhedged. The hedged foreign currency exposure (as a percentage of the total foreign currency exposure in the fund) is 84.00% (unhedged 16.00%).
