Pie Funds Management Scheme: Pie KiwiSaver Growth Fund

This fund update was first made publicly available on 30.04.24

What is the purpose of this update?

This document tells you how the Pie KiwiSaver Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Pie Funds Management Limited (**Pie Funds**) prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Pie KiwiSaver Growth Fund seeks to maximise capital growth for members over a period exceeding 7 years. The Fund invests primarily in International and Australasian equities with a focus on globally-known brands, along with a cash and fixed interest exposure, directly and/or through investment in other funds also managed by Pie Funds.


How has the fund performed?

What fees are investors charged?

Investors in the Pie KiwiSaver Growth Fund are charged fund charges. In the year to 31 March 2024, these were:

Investors may also be charged individual action fees for specific actions or decisions (for example, for withdrawing from or switching funds, although these are not currently charged by Pie Funds).

Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.

Lucy had \$35,000* in the fund at the start of the year and did not make any further contributions. At the end of the year, Lucy incurred a gain after fund charges were deducted of \$5,682 (that is 16.23%** of her initial \$35,000). Lucy did not pay any other charges. This gives Lucy a total gain after tax of \$5,326 for the year.

*This figure has been used as it represents close to the average contributing KiwiSaver Scheme member's balance in 2022 (estimate provided by FMA).

**This is the percentage return after duducting the total fund flat fee of \$240 p.a. Fee based on fund balance of \$35,000.

Target investment mix

- Cash and cash equivalents 5%
- New Zealand fixed interest 5%
- International fixed interest 10%
- International equities 65%
- Australasian equities 15%

Hedging: We actively manage all currency exposure. It is not our intention to 100% hedge the currency at all times; some overseas securities may be unhedged. The hedged foreign currency exposure (as a percentage of total foreign currency exposure of the fund) is 91.15% (unhedged 8.85%).
