#### What is the purpose of this update?

This document tells you how the Pie KiwiSaver Aggressive Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Pie Funds Management Limited (**Pie Funds**) prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

#### Description of this fund

The Pie KiwiSaver Aggressive Fund seeks to maximise capital growth for members over a period exceeding 10 years. The Fund invests primarily in International and Australasian equities directly and/or through other funds also managed by Pie Funds.

Investors may also be charged individual action fees for specific actions or decisions (for example, for withdrawing from or switching funds, although these are not currently charged by Pie Funds).


#### Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.

Lucy had \$35,000\* in the fund at the start of the year and did not make any further contributions. At the end of the year, Lucy incurred a gain after fund charges were deducted of \$4,092 (that is 11.69%\*\* of her initial \$35,000). Lucy did not pay any other charges. This gives Lucy a total gain after tax of \$4,092 for the year.

#### What does the fund invest in?

This shows the types of assets that the fund invests in.<sup>2</sup>



**Hedging:** We actively manage all currency exposure. It is not our intention to 100% hedge the currency at all times; some overseas securities may be unhedged. The hedged foreign currency exposure (as a percentage of total foreign currency exposure of the fund) is 71.32% (unhedged 28.68%).

<sup>\*</sup>This figure has been used as it represents close to the average KiwiSaver Scheme member's balance as per 2024 FMA KiwiSaver Statistical return.

<sup>\*\*</sup>As the fund has not been in existence for a full calendar year, the figures in this example are based on the market index annual return less the actual fund fees.

## **Notes**
