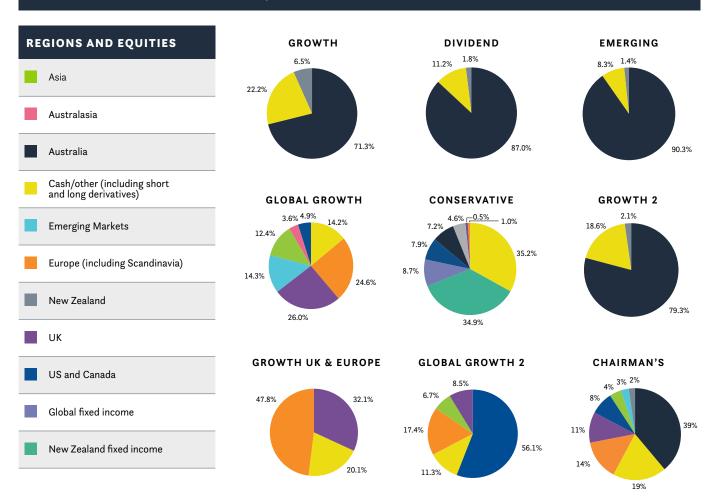

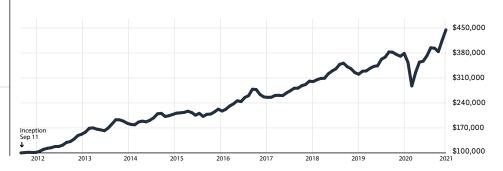
DIVIDEND

If you had invested \$100,000 at inception, the graph below shows what it would be worth today



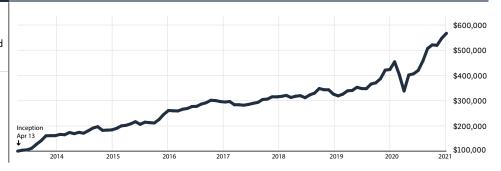
EMERGING

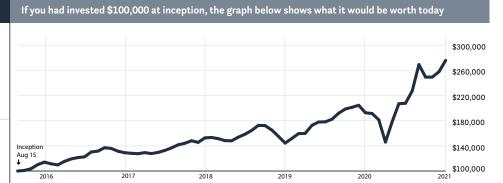

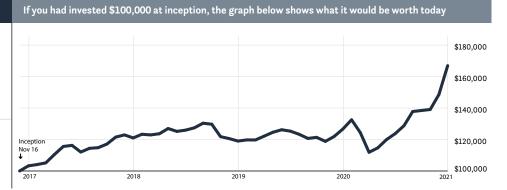

Annualised return since inception (After fees and before tax)

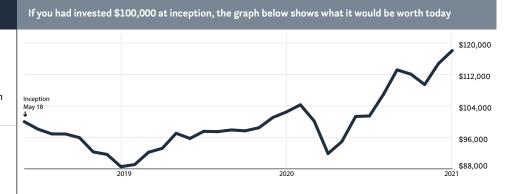


GLOBAL GROWTH 2

Annualised return since inception (After fees and before tax)

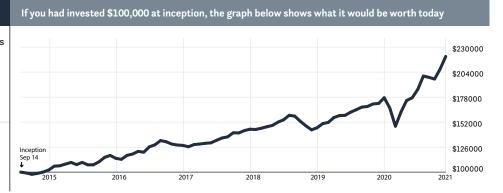
