#### What is the purpose of this update?

This document tells you how the Pie Climate Friendly Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Pie Funds Management Limited (**Pie Funds**) prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

#### **Description of this fund**

The Pie Climate Friendly Fund seeks to provide investors with long-term capital growth, by investing in large global companies, over a rolling three-year period. The Fund will invest predominantly in companies with lower exposure to carbon emissions and fossil fuel reserves.

## What are the risks of investing?

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

The MSCI ACWI Low Carbon Leaders Index is based on the MSCI ACWI Index, its parent index, and includes large and mid-cap stocks across 23 Developed Markets (DM) and 23 Emerging Markets (EM) countries\*. The index addresses two dimensions of carbon exposure — carbon emissions and fossil fuel reserves — providing clients with an effective tool for limiting the exposure of their portfolios to carbon risk. By excluding companies with the highest carbon emissions intensity and the largest owners of carbon reserves per dollar of market capitalization, the index aims to achieve at least 50% reduction in its carbon footprint. The index also aims to maintain wide and consistent market exposure by minimizing the tracking error relative to the MSCI ACWI Index. The MSCI Global Low Carbon Leaders Indexes use MSCI ESG CarbonMetrics data from MSCI ESG Research Inc.

### What fees are investors charged?\*

Investors in Pie Climate Friendly Fund are charged fund charges. As the fund has not been in existence for the whole of the most recent scheme year, our best estimate of the total annual fund charges are<sup>2</sup>:

\*The fees are represented as a percentage of net asset value (NAV). While Pie Funds charges fees as a percentage of gross asset value (GAV); the law insists the fees be disclosed as a percentage of NAV. As a result, there will be discrepancies between the fees set out in this document and the actual fees incurred.

#### Example of how this applies to an investor\*


Small differences in fees and charges can have a big impact on your investment over the long term.

Lucy had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Lucy incurred a loss after fund charges were deducted of \$1,076 (that is -10.76% of her initial \$10,000). Lucy did not pay any other changes. This gives Lucy a total loss of \$1,076 for the year.

\*As the fund has not been in existence for a full calendar year, the figures in this example are based on the market index annual return less the estimated fees above. The actual total return since inception is -11.45 after charges and tax at 28% PIR.

#### What does the fund invest in?

This shows the types of assets that the fund invests in.5



**Hedging:** We actively manage all currency exposure. It is not our intention to 100% hedge the currency at all times; some overseas securities may be unhedged. The hedged foreign currency exposure is 74.72% (unhedged 25.28%).

#### **Notes**

- 1. As the Fund has not been in existence for five full years, its risk category has been calculated using market index returns as well as actual returns. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. Market index returns have been used for the period from 1 January 2014 31 March 2018.
- 2. As the fund commenced on 1 May 2018, a full scheme year had yet to be completed. Therefore in accordance with clause 63(4) of schedule 4 of the Financial Markets Conduct Regulations 2014 (FMC Regulations), instead of providing the actual total fund charges for the fund, we have provided the total annual fund charges calculated as a percentage of net asset value based on a best estimate of the relevant charges in accordance with clause 32 of schedule 4 of the FMC Regulations.
- 3. The determination of these fees is based on estimates based on Pie Funds' experience with other schemes it manages.
- 4. The determination of these fees is based on estimates using the market index (MSCI ACWI Low Carbon Leaders Net Total Return Index USD) average annual return for the last 5 years, as the fund has only been in existence since 1 May 2018.
