What is the purpose of this update?

This document tells you how Pie Chairman's Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Pie Funds Management Limited (Pie Funds) prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Pie Chairman's Fund will seek to provide investors with long term capital growth by investing predominantly in the other Pie Funds products. The other Pie Funds products focus on investment in Australian, New Zealand and Global listed equities of Smaller, Emerging and Medium Companies, where Pie Funds considers the value is greatest and the opportunity of earnings growth is high. Like the other Pie Funds products, direct investments may be made in hand-picked listed Australasian and New Zealand Smaller, Emerging and Medium Companies. In addition, the Pie Chairman's Fund may also invest in unlisted equities and other types of financial products such as cash at our discretion.





Small differences in fees and charges can have a big impact on your investment over the long term.

Example of how this applies to an investor

Lucy had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Lucy received a return after fund charges were deducted of \$2,353 (that is 23.53% of her initial \$10,000). Lucy did not pay any other charges. This gives Lucy a total return after tax of \$2,333 for the year.
