PIE FUNDS MANAGEMENT SCHEME: PIE AUSTRALASIAN EMERGING COMPANIES FUND

Fund update for the quarter ended: 31.03.17

This is a replacement fund update and replaces the previous 31 March 2017 version. The change reflected is to the benchmark index used for comparative purposes to ensure compliance with the regulations governing this fund. The new benchmarks now incorporate dividends in calculating returns. This version will be first made publicly available on 14 June 2017.

What is the purpose of this update?

This document tells you how the Pie Australasian Emerging Companies Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Pie Funds Management Limited (Pie Funds) prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Pie Australasian Emerging Companies Fund will seek to provide investors with long term capital growth by investing predominantly in a concentrated portfolio of hand-picked Emerging Companies, where Pie Funds considers value is greatest and the opportunity of earnings growth is high. The Pie Australasian Emerging Companies Fund may also invest in other types of financial products such as cash and unlisted equities.

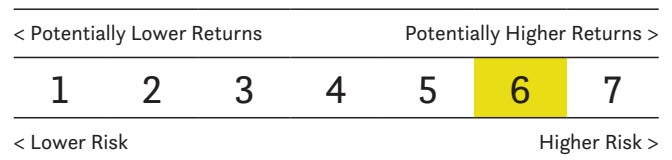

What are the risks of investing?

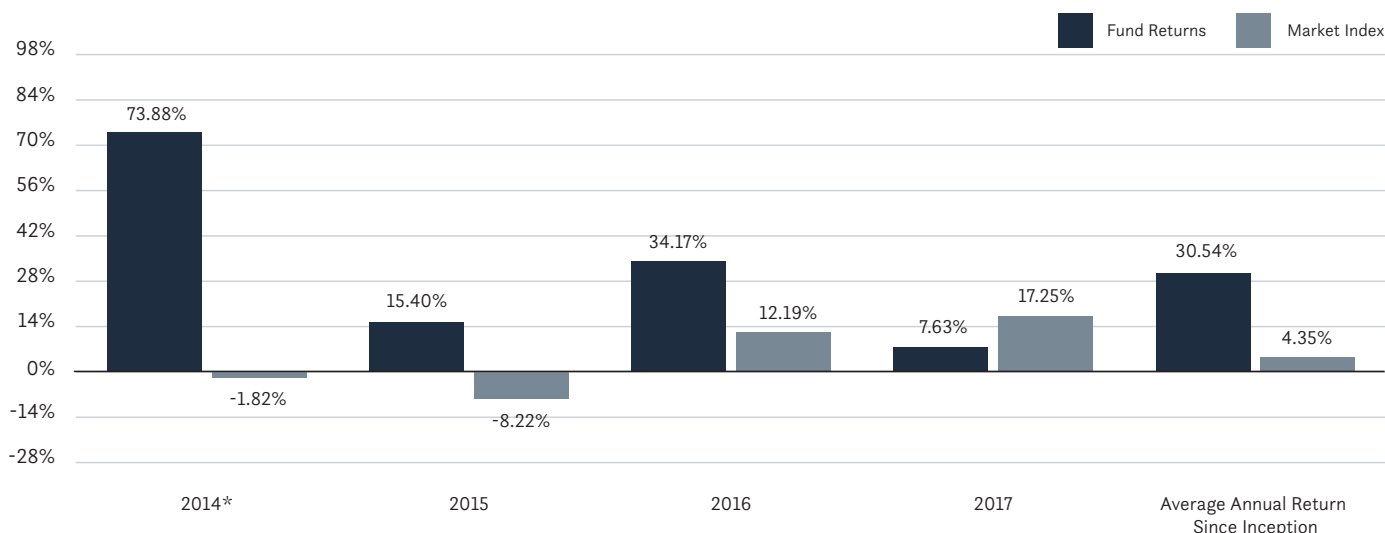

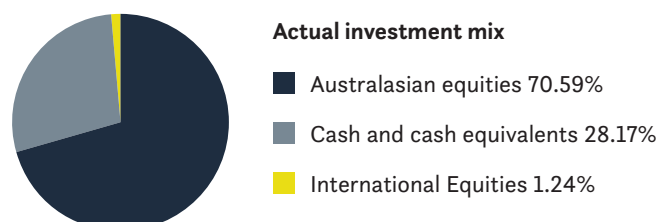
Small differences in fees and charges can have a big impact on your investment over the long term.

Example of how this applies to an investor

Lucy had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Lucy received a return after fund charges were deducted of \$681 (that is 6.81% of her initial \$10,000). Lucy did not pay any other charges. This gives Lucy a total return after tax of \$763 for the year.
