What is the purpose of this update?

This document tells you how the Pie Australasian Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Pie Funds Management Limited (**Pie Funds**) prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Pie Australasian Growth Fund will seek to provide investors with long term capital growth by investing predominantly in a concentrated portfolio of hand-picked listed Australian and New Zealand Smaller Companies, where Pie Funds considers value is greatest and the opportunity of earnings growth is high. The Pie Australasian Growth Fund may also invest in other types of financial products such as cash and unlisted equities.

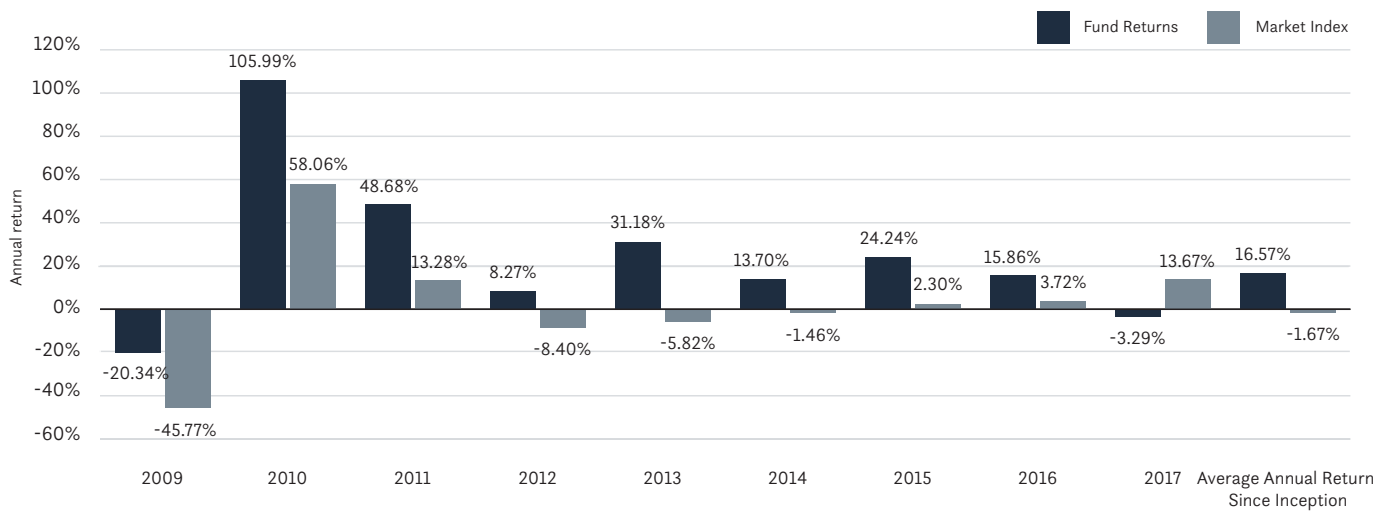

Investors may also be charged individual action fees for specific actions or decisions (for example, for withdrawing from or switching funds, although these are not currently charged by Pie Funds). Small differences in fees and charges can have a big impact on your investment over the long term.

*The fees are represented as a percentage of net asset value (NAV). While Pie Funds charges fees as a percentage of gross asset value (GAV); the law insists the fees be disclosed as a percentage of NAV. As a result, there will be discrepancies between the fees set out in this document and the actual fees incurred.

Example of how this applies to an investor

Lucy had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Lucy incurred a loss after fund charges were deducted of \$1,693 (that is 16.93% of her initial \$10,000). Lucy did not pay any other charges. This gives Lucy a total loss after tax of \$1,657 for the year.
