## PIE FUNDS MANAGEMENT SCHEME: PIE GLOBAL SMALL COMPANIES FUND

### Fund update for the quarter ended: 31.03.18

This fund update was first made publicly available on 27.04.18

### What is the purpose of this update?

This document tells you how the Pie Global Small Companies Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Pie Funds Management Limited (**Pie Funds**) prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### Description of this fund

The Pie Global Fund is a P.I.E. registered fund that invests predominantly directly in globally listed Smaller Companies, managed funds from around the world that focus investment on Smaller Companies and cash. The fund seeks to provide investors with long term capital growth.

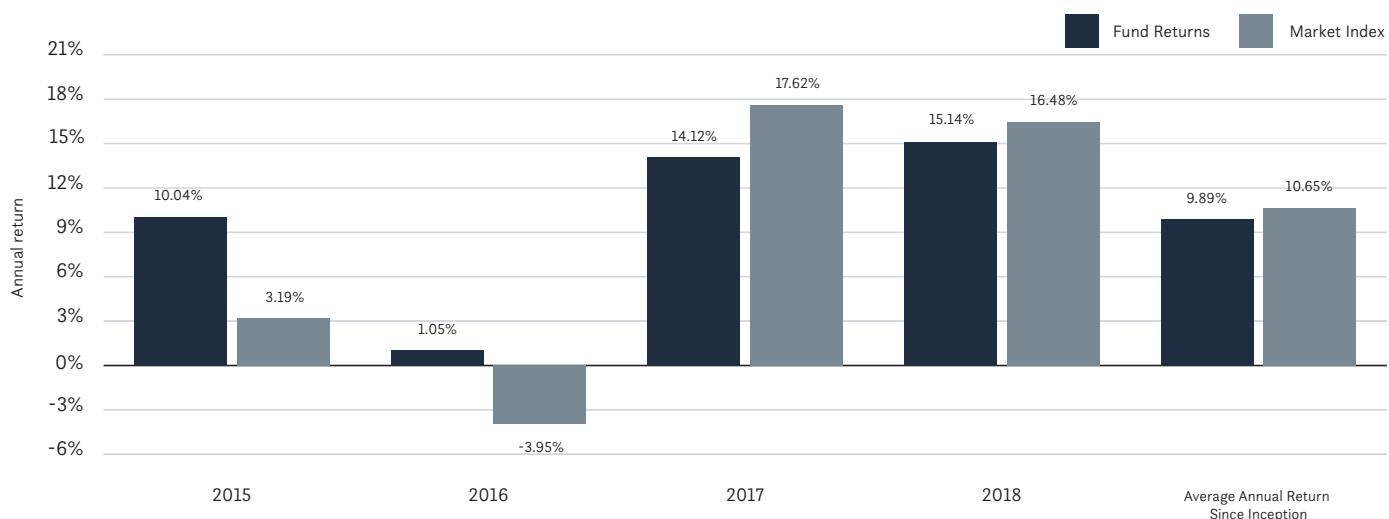

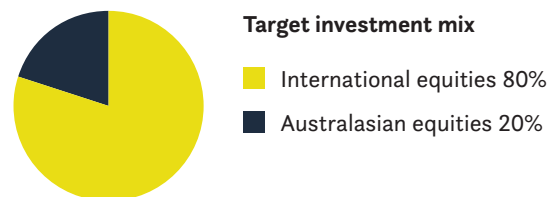
## Example of how this applies to an investor

Lucy had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Lucy received a return after fund charges were deducted of \$1,505 (that is 15.05% of her initial \$10,000). Lucy did not pay any other charges. This gives Lucy a total return after tax of \$1,514 for the year.

## What does the fund invest in?

This shows the types of assets that the fund invests in.<sup>2</sup>

We actively manage all currency exposure. It is not our intention to 100% hedge the currency at all times; some overseas securities may be unhedged.
